<p>General Fund: The Board of Education of the Central Square Central School District, County of Oswego, State of New York, be authorized to incur expenditures not exceeding \$65,055,972 (U.S. Dollars: Sixty-Five Million, Fifty-Five Thousand, Nine Hundred and Seventy Two) or so much as necessary for its General Fund operating expenses during the school fiscal year beginning July 1, 2011, and ending June 30, 2012, and to levy a tax on the taxable property of the School District sufficient to meet the amount of this sum not received from other sources.</p> <p>VOTE: 896 Yes, 405 No</p>	<p><u>General Fund</u></p>												
<p>School Transportation Vehicles: Shall the Board of Education of the Central Square Central School District, be authorized to acquire 5-65 passenger school buses, 3-24 passenger school buses at an estimated cost not to exceed \$690,950 and to expend therefore, \$650,950, which is estimated to be the total cost thereof, and levy a tax for the foregoing in the amount of \$650,950, which shall be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education and issued at one time, or from time to time, in the principal amount not to exceed \$650,950, and a tax is hereby voted to pay the interest on said obligations when due.</p> <p>VOTE: 879 Yes, 401 No</p>	<p><u>School Transportation Vehicles</u></p>
